Rules

The more egg masses scraped, the more entries into the draw. **Please limit number of entries to no more than two (2) per person.** The winner will be randomly selected. Only residents of Ontario, Canada are eligible for entry into the contest.

For verification, Contest participants are asked to take a photo after their trees are scraped and submit it to the entry form where asked.

Following each draw the winner will be contacted via the provided email for notification and mailing address request to receive their prize. Only the winners will be notified via the provided email.
