- **Draw time:** Winner drawn on Monday, Aug. 17
- **Prize:** Prize pack valued at approx. \$200.
- **No purchase necessary:** Free to enter.
- **Odds:** Depends on number of entries received.
- **Winner notification:** The winner will receive an email to verify eligibility and collect shipping information.
